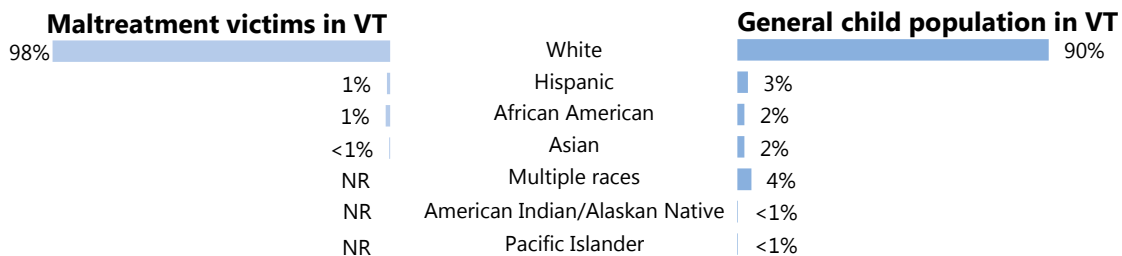

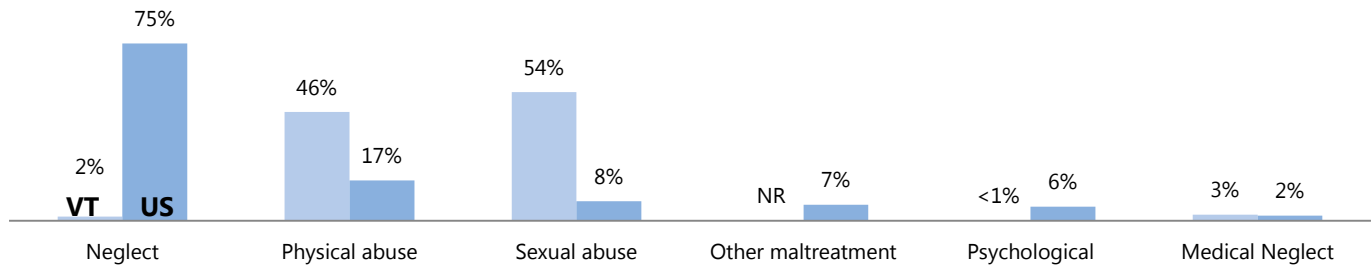

<sup>2</sup> This reflects a "unique count of children who had a maltreatment report investigated or assessed" (i.e., a child who had at least one maltreatment report investigated/assessed was counted once, regardless of how many investigations/assessments they had).

<sup>3</sup> Unless noted otherwise, data on victims represents "unique victims" (i.e., a child is counted once regardless of how many times s/he was determined to be a victim of maltreatment).

<sup>4</sup> Hispanic children are not included in counts for specific racial groups. Children whose race was reported as unknown are not included. Data for the general child population under age 18 is from the U. S. Census Bureau. This information is publicly available on the Kids Count Data Center (<http://datacenter.kidscount.org/data/tables/103-child-population-by-race>).

<sup>5</sup> Fields with "NR" signify that the data was not reported or available in the 2014 Child Maltreatment Report. See Appendix D of the report for more detailed information by state.

<sup>6</sup> Total may exceed 100%. Children who experienced more than one type of maltreatment were counted in each applicable category.

<sup>7</sup> In the Child Maltreatment 2014 report, perpetrators and relationships are only counted once regardless of the number of times the perpetrator was reported. Previous reports counted each relationship and percentages of relationships totaled more than 100 percent.

<sup>8</sup> Child daycare provider, foster parent, friends or neighbors, legal guardian, other, other professional, other relative, group home and residential facility staff, unmarried partner of parent, multiple relationships, or unknown.

<sup>9</sup> NCANDS collects data for 26 types of services including but not limited to adoption, foster care, family preservation, mental health, and substance abuse. Postresponse services are defined as services that were delivered between the date the report was received and up to 90 days after the disposition date. Duplicate count of victims (i.e., a single child was counted for each postresponse event s/he had). Foster care services are defined as activities associated with 24 hour substitute care for children placed away from their parents or guardians and for whom the State Title IV-B/IV-E agency has responsibility for placement, care, or supervision.
